विश्वनाथ प्रताप सिंह क्रांति के उस बीज पुरूष को नमन्

वीपी नहीं हैं। लेकिन उनके होने ओर न होने के बीच जो बारिक रेखा थी उसे यदि किसी ने सबसे ज्यादा समझा तो वे थी इस देश की मीडिया और देश का एक खास तबका, जिसे उनका होना जितना अधिक सालता था उससे अधिक उनका न होना आह्लादित कर देता है। क्रांति के उस बीज पुरूष को नमन् जिसने अपने ऐतिहासिक राजीतिक फैसले का उद्घोष जब 7 अगस्त 1990 को विश्व के दूसरे सबसे बड़े लोकतंत्र भारत के संसद सदन में रखा तो पूरी भारतीय राजनीति में एक भुचाल आ खड़ा हुआ। सारी दुनिया भारतीय लोकतंत्र की जड़ों को देखने लगी। वो फैसला था — वी.पी.सिंह के शब्दों में:

"इस वैभवपूर्ण सदन में सामाजिक न्याय के एक महत्वपूर्ण फैसले की घोषणा करते हुए आज मैं प्रसन्न हूँ, जिसे मेरी सरकार ने मंडल कमीशन की रिपोर्ट के आधार पर सामाजिक एवं शैक्षणिक रूप से पिछड़े वर्गों के लिए लिया है। माननीय सदस्यों (डच्चे) आप जानतें है, 40 साल पहले संविधान स्वीकार करते समय आर्टिकल 340(1), 15(4) और 16(4) के संदर्भ में यह सोचा गया था कि सामाजिक एवं शैक्षणिक रूप से पिछड़े वर्गों (SEBCs) की पहचान की जाएगी, उनकी तकलीफें दूर होंगी एवं उनकी दशा में सुधार किया जाएगा। यह हमारे संविधान के मूल स्वरूप के प्रति नकार है कि आज तक उनकी ये जरूरते पूरी नहीं हो पायी।"

और इस तरह <u>एक अविस्मरणीय दिन</u> <u>7 अगस्त 1990 को देश के कद्दावर नेता और माननीय प्रधानमंत्री वी.पी.सिंह की सरकार ने सामाजिक एवं शैक्षणिक रूप से पिछड़े वर्गों के लिए नौकरियों में 27 प्रतिशत सीटों का आरक्षण सुनिश्चित कर दिया।</u>

वीपी अमर हैं। आज वे एक पर्याय हैं, एक प्रतीक हैं। एक ऐसे प्रकाशपुंज है जो हमेशा हम सबके भीतर अनश्वर की तरह मौजूद रहेंगे। अब इसे अपराध मानो या देश की 62 प्रतिशत अन्य पिछड़े वर्गों की आबादी के प्रति सामाजिक न्याय के रास्ते में एक सार्थक कदम। लेकिन यह एक मृत्यु का फरमान था जिसे वीपी ने अपनी ही सरकार के गाल पर लिख दिया। चंद महीनों में सरकार गिर गई और अपने भी दुश्मन बन गए। गंदी से गंदी गालियां मिली। क्रोध इस बात पर था कि क्यों नहीं इसे भी कुड़े के ढेर में डाल दिया गया जैसे कि 1955 में श्री काका कालेलकर की अध्यक्षता में आयी प्रथम पिछड़ा वर्ग आयोग की रिपोर्ट जान बूझकर दबा दी गइ थी। मित्रों, वॉइस ऑफ ओबीसी का प्रवेशांक में हमने यह सूचना अपने पाठकों को दी थी। आज 27 नवम्बर को उनकी पुण्यतिथि के अवसर पर एक बार पुनः उनके इस फौलादी हौसले को सलाम करते हुए नमन करते हैं।

Please refer to your letter on ensuring Social Justice and Social Diversity in the appointment of Judges to the Hon'ble Supreme Court of India and Hon'ble High Courts.

2. I would like to inform you that the appointment of Judges of the Supreme Court and High Courts is made under Articles 124, 217 & 224 of the Constitution of India respectively; which do not provide for reservation for any caste or class of persons. However, the Government has been requesting the Chief Justices of High Courts that while sending proposals for appointment of Judges, due consideration be given to suitable candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Minorities and Women to ensure social diversity in appointment of Judges in High Courts.

- 4. The Trust will help the meritorious students for their education at +2 level, Graduate and postgraduate levels.
- 5. For the carrier progression, coaching, special training for skill development etc can be imparted or offered to the OBC/SC ST/UR employees of Union Bank of India for empowering them. Pre-Recruitment Training for fresh OBC candidates, who will be appearing for Jobs in Union Bank of India or through IBPS, can also be organized by the Trust.

To conduct health education programmes and Human rights programmes, such as providing free legal aid, Human rights awareness, free blood testing camps, Anti HIV and rehabilitation for deprived people and juvenile including in Commercial Sex work for creating awareness programmes to widen the knowledge on medicine and Health for the deprived people.
- 30. To provide accommodation such as food, shelter, cloths for orphans, helpless children, blind, deaf and dumb and helpless women and Transgender.
- 31. To promote tailoring, embroidering and other readymade garments & recycling activities for deprived people by providing training programmes and creating job opportunities
- 32. To promote uplift of deprived people by educating them on handicrafts such as coir craft and other handicrafts.
- 33. To do all such other lawful things as may be incidental to or conductive to the attainment of the above objects.
- 34. To study the problem of Local Areas, States of India as well as Weaker Sections of the people and focus attention on them.
- 35. To enable the socially, educationally and economically deprived people of India to realize and fulfil their responsibilities in themselves, in society to the country and the world.
- 36. To bring together and co-ordinate the activities or and affiliate regeneration working for the welfare of the socially, educationally and economically deprived people.
- 37. To undertake all welfare programmes for Ex- Servicemen's children's through educational, medical and all other social activities for upliftment of his family.
- 38. To raise funds and to receive donations, contributions, gifts and subscriptions for carrying out the objects of the Trust.
- 39. To undertake all welfare programmes for women and Children implement to State and Central.
- 40. To publish books, periodicals & leaflets high lighting the problems of backward classes and also propaganda the thoughts of social justice leaders such as Periyar, Ambedkar, Jothirao pule, and others.
- 41. Main objects of the trust is to the welfare of backward classes and schedule castes.

It would be modeled on the lines of Andhra Pradesh and Telangana," civil supplies minister Chhagan Bhujbal said in Mumbai after a Cabinet meeting on Wednesday.



The Maharashtra cabinet has cleared an ordinance to reserve seats for *Other Backward Classes in local body seats.* The ordinance will have immediate effect in upcoming by-elections to a set of local governing bodies, while adhering to the Supreme Courtmandated 50% ceiling on reservation. The

governor is expected to promulgate the

ordinance shortly.

The OBC quota became a hot issue in Maharashtra after the Supreme Court quashed the state plan to reserve 27% electoral seats in local bodies for OBCs.


