ALL INDIA UNION BANK OBC EMPLOYEES' WELFARE ASSOCIATION

Our OBC Association, founded on **January 1996** and We have completed 25 years of our service in the cause of empowerment of our OBC employees in our bank, in particular and society in general.

25 years is certainly a long journey for any Association. During this period, we were able to address the concerns of our members effectively and have come a long way in our efforts in protecting and promoting the interests of our OBC employees in our bank.

Our members fully understood the purpose of our OBC Association and extended their co-operation in full measure that led to this success and growth.

Our All India body, is having IR meetings with Central management and co-ordinating all the State Units. The effective role of our AIOBC Federation, the national organization of OBC associations, in achieving certain guidelines and orders from the Ministry of Finance were one of the reasons for our success.

At this juncture, it must be remembered of the support given by our Management in extending certain facilities and opportunities for our OBC members which we would like to thankfully register and acknowledge:

1. Periodical Meetings with Central Office as well as with Regional Offices.

2. Liaison Officers at Central Office at all Zonal and Regional Offices.

3. Pre-promotion Training to OBC employees:

- i) **5 days** Pre-promotion training to OBC employees are conducted at all the States to OBC employees appearing for promotion up to Scale III – i.e. **Sub-staff to Clerk, Clerk to Scale I to II, II to III.**
 - ii) **3 days** pre-promotion training is imparted for OBCs appearing for promotion from **Scale III to IV** (Chief Manager) and **IV to V** (Asst. Gen. Manager).
 - iii) **The State level OBC Associations are permitted to organize and conduct pre-promotion training for OBCs in their respective States in co-ordination with HR Department of respective ROs /ZOs. Management reimburses all the expense incurred by the Association. The participants are treated as on duty and training given with all the infrastructure facilities including faculty, study material etc. In addition, the Sub-staff and Clerks attending these training programs were reimbursed Lodging expenses to the extent of Rs.1600 (Scale I officer eligibility) with TE/DA.**
4. **Workshop on Reservation policy for 3 days** is imparted every year to the representatives of the OBC Associations at different Staff Training Colleges and so far, 18 such workshops were conducted by the Bank for OBC representatives, the recent one in **February, 2020 at STC, Bengaluru.**
 5. **Workshop on Disciplinary Proceedings for 3 days** was also conducted for the OBC representatives.
 6. **Fully furnished Office for the All India OBC Association was provided by the Bank at Union Bank Bhavan, Zonal Office Building, Broadway, Chennai.**
 7. Our Association, while ensuring the implementation of the above facilities is conducting pre-recruitment training to OBC applicants appearing for IBPS / SSC examinations and imparting knowledge on social justice, which we consider as our duty to the society.
 8. We are happy to inform that **Thiru.T.K.S.Elangovan, Member of Parliament** is the **Patron** of our All India Union Bank OBC Employees Welfare Association. He is also the member in the **Parliamentary Committee for OBC.**

Above are just a **glimpse** of the rights secured by our Association and at ground level, we are in close contacts with our members on daily basis and our office-bearers both at the All India and State

level try their best to address the concerns and issues of the members by taking up with the Management.

Our **All India Union Bank OBC Association** is affiliated with **All India Federation of OBC Employees' Welfare Associations, the national organization representing the OBC employees of Central Government and Public Sector Undertakings.**

The **AIOBC** Federation has nearly **50 OBC Associations** as affiliates and taking up the cause of OBCs with the Government .

Shri.V.Hanumantha Rao, Ex.MP and former Convener of OBC MPs forum that played a pivotal role in bringing Central Educational Institutions Act, 2007, Parliamentary Committee for OBC and Constitutional Powers for NCBC, is our President of the Federation.

- ✓ Written book on **"69% Reservation Act"** (Tamil) and within two months, 2000 books has been sold. Now, English translation is also available.
- ✓ Written booklets on **"OBC Reservation"** and **"Creamy layer concept"**.
- ✓ Associated with Periyar movement to spread the message and ideology of Periyar.
- ✓ **Conferred "Dr.K.Veeramani Award for Social Justice"** by Periyar International, Chicago, USA on 9th January 2011, for life long contribution to social justice.
- ✓ Instrumental in forming **"OBC MPs Forum"** at Delhi under the leadership of Hon'ble Mr.V.Hanumantha Rao, Ex.MP.
- ✓ Associated with the Government in bringing constitutional amendment to provide 27% reservation to OBCs in Central Educational Institutions.
- ✓ Associated with OBC MPs Forum in forming a Parliamentary Committee for OBC.
- ✓ **Invited by Parliamentary Committee on Personnel, Pensions and Public Grievances** headed by Dr.E.M.Sudarsana Natchiappan to submit views on SC/ST and OBC Reservation Bill in 2005.

- ✓ Invited by Select Committee headed by Shri.**Bhupendra Yadav** in 2017 to present views on constitutional powers to NCBC (102nd amendment bill), where from our Federation informed that the Bill will take away the powers of the States in identifying OBCs.
- ✓ **Invited by Justice Rohini Commission** on Sub-Categorization in January 2018 to submit views on categorization of OBC castes.
- ✓ Exposed the '**zero reservation' policy**' adopted by Central Government in Medical Admission under All India Quota seats contributed by the States.
- ✓ Govt. of Tamil Nadu headed by Hon'ble Chief Minister **Thiru.M.K.Stalin** nominated **G.Karunanidhy** as a **Member in the Social Justice Monitoring Committee** to look into the implementation of **69% reservation policy** in Govt. Departments, Educational Institutions.
