At the outset **Sri Ravindra Ram**, Advisor of AIUBOBCEWA welcomed all the dignitaries with shawl and bouquet on the dais


and briefed about the Association and the glory of city of Varanasi.

Honorable Vice Chairman of National Commission of Backward Classes Dr. Lokesh Kumar Prajapati addressed the august house. He categorically spoke that if reservation is a curse then it should be provided 100% and should be given as per population of the community. 76% of the people are getting even 50% of the govt job and 24 % are getting more than 50% jobs. 253 IAS qualified OBCs students have denied the job allocation. Creamy Layer calculations are not fair. He has written a letter to the Social Justice Empowerment Ministry and honorable Prime Minister on the subject. He also assured that representation of OBC executives would be taken care.

GM & Liaison Officer for OBC Shri G.R. Padalkar in his speech told that OBC fraternity of our Bank would be benefited through dialogues with the management. Issues are sorted out with mutually agreed opinions. I appreciate the positive stand of the Association.

DGM HR Shri D. Chiranjeevi invited the attention of the employees of the Bank towards taking promotions. The second session of the conference **General Body** was held in afternoon. At the out set of the GB, founder members of the association were honored by the association. Except Shri Ashok Kumar, CM, Indore (Photo inserted) all founder members (from left): • Shri Binod Prasad Sharma • Dr. Amritanshu • Shri Mithilesh Kumar • Shri Umesh Kumar • Shri Sunil Kumar • Shri D.D. Prasad (Extreme right is Shri Ravindra Ram) have presided the meeting. Members, Representatives have attended the function from all across the districts of Uttar Pradesh like; Ghazipur, Gorakhpur, Jaunpur, Azamgarh, Varanasi, Meerut, Kanpur, Saharanpur, Chandauli, Lucknow etc. Special invitees from Bihar Shri Upendra Yadav, Pawan Kumar and team, from Kolkata Shri Prakash Majumdar and team, from Mumbai Shri Vijay Kurdarkar were present.

Dr. Amritanshu presented the General Secretary Report. Important points of the GS Report are:

- (1) Association should own its office or purchase land for the same.
- (2) Founder Members will be lifelong Executive Committee Member in every constituted new Governing Body of the Association.
- (3) Enhancement of Association fee Rs. 40 for Sub Staff, Rs 60 for Clerks & Rs 100 for Officers.
- (4) RESOLUTION has been adopted by the house (Published on 4<sup>th</sup> Page)

GS Report has also focused on Women Reservation Bill, Welfare measures taken by GoI as well as State Govt. GS Report also has voiced against the step taken by GoI regarding equivalence of post in determining creamy layer through which all officers of PSBs are classified in Group A / Class 1.

Some of the delegate members have put their views on GB Report. Founder members have also spoken on the report. Thereafter Accounts Statement for the year 2018-2019 was presented by the Asstt. Treasurer Md. Jalaluddin. The house assembled in the General Body approved the General Secretary Report and Balance Sheet of the Association with clapping and applauded voice.

# Nomination of names for the new Governing Body

Soon after approval of the GS Report and Balance Sheet, Adviser of *All India Union Bank Backward Classes Employees Welfare Association* Shri Ravinddra Ram dissolved the body for constituting new Governing Body of Office Bearers. # RESOLUTION

## Adopted at the 3<sup>rd</sup> conference of Union Bank Backward Classes Employees Welfare Association, Up on 13<sup>th</sup> July 2019

Request to Union Bank Management to consider the following matters for implementation:

#### 1. Implementation of Finance Ministry Order dated 6.11.2013:

Consequent to the **oral evidence and discussion with Parliamentary Committee for OBC with Department of Financial Services, Ministry of Finance,** GO has been issued by DFS, Ministry of Finance, vide F.No.2/02/2013-Welfare dated 6<sup>th</sup> November 2013 to all Public-Sector Banks, FIs, PSICs, RBI, IRDA to extend various facilities.

#### Para 2 of the above GO, it has been mentioned as under:

Besides above, the feasibility of implementation of the following issues emerging during discussions with the Parliamentary Committee, or raised by different OBC employees' welfare associations also need to be considered, subject to exigencies and with the approval of the respective Board, if not already undertaken:

- a) Separate Cell for OBC employees.
- Providing pre-recruitment and pre-promotion training to OBC employees to bring them at par with other employees.
- Nomination of adequate number of OBC employees for Seminars, symposia, conferences and foreigntraining to enhance their skills

#### 2. Eight days Pre-promotion training to OBC employees:

While the management permits our Association to conduct 5 days prepromotion training, the management is conducting 8 days training to SC/ST employees in all the cadres from Sub-staff to Officer Scale III cadre.

We once again request that Union Bank management may be directed to conduct 8 days pre-promotion training to OBC employees as is given to SC/ST employees of Union Bank of India.

#### 3. Pre-recruitment training to OBC candidates:

Bank is recruiting Clerks and Probationary Officers thro' IBPS. While so, the OBC candidates are not given any pre-recruitment training, whereas, SC/ST and Minority candidates are given pre-recruitment training, Ministry of Finance vide their GO dated 6.11.2013 has recommended pre-recruitment training to OBC candidates.

But so far, this facility has not been given to OBC candidates. Even in respect of Specialized Officers recruitment made by Union Bank directly, such facility has not been extended.

### Quarterly Meetings at Central Office and in Zonal/Regional Offices:

It is our request that OBC representatives in Union Bank of India be called for quarterly meetings by the Management at Central Office level as well as at Zonal and Regional Office level to discuss reservation policy related matters and OBC grievances.

**SC/ST representatives have been given quarterly meetings** at Central Office, Zonal and Regional Office level.

### 5. Recruitment of Armed Guards:

**Ministry of Finance vide its Order dated 3.7.2014** has directed the Banks to reserve 24.5% of the Group D posts to Ex-Servicemen.

Whereas, Union Bank has stopped recruiting Ex-servicemen as Armed Guards which comes under Group D category and has outsourced the posts.

While the duties of these outsourced personnel are same as the existing Armed Guards, they are paid by the contractors on contract basis and there will not be any other facilities as is being received by the existing Armed Guards.

In view of this approach of Union Bank in outsourcing the Armed Guards posts, the Bank can never fulfill the directive of Ministry of Finance to reserve 24.5% of the Group D posts to Ex-servicemen.

#### Resolution demanding Central Government to consider the following:

- Implementation of Mandal Commission Recommendations and to raise reservation percentage of OBCs from 27% to 52%.
- Withdrawal of DoPT order dated 6.10.2017 and to consider the recommendations of Parliamentary Committee for OBC. (Report dated 9.3.2019)
- 3. Separate Ministry for OBC (Other Backward Classes)
- 4. Reservation in promotion
- 5. Caste-wise data to be collected in the ensuing Census enumeration 2021.
- 6. Reservation Bill for OBC.
