Request to constitute the new NCBC

We would like to state that term of the NCBC headed by Dr.Bhagwal Lal Sahni has ended by February 2022 including the terms of the Hon'ble Members.

At present, there is no functioning of the NCBC and lots of representations from the backward classes remains unattended.

The records of the Commission's composition shows that every time, the new Commission is constituted only after few months and at times, as in the case of the last Commission, was constituted after a lapse of nearly 2 ½ years.

The Government headed by respected Prime Minister Shri.Narendra Modi extended constitutional powers to NCBC way back in 2017 but without Chairperson and Members, important matters relating to welfare of OBCs could not be taken in the absence of a full fledged Commission.

We therefore request your goodself to kindly give this matter top priority and to constitute the NCBC at the earliest.
