- First structured meeting of the Association with the Central Management held at CO, Mumbai in 1997.

G. Karunanidhy at **Chennai (TN)** in 1994, immediately after enactment of Mandal Commission law on 08.09.1993 afterwards it spread in other states like Bihar, Kerela, Uttar Pradesh, Rajsthan, Mumbai etc.

- **UP State Body** was formed in 1998 by **Dr. Amritanshu** with his 6 other friends called **Founder Members**. They are **Shri Dharmdeo Prasad, Shri Binod Prasad Sharma, Shri Mithilesh Kumar, Shri Ashok Kumar, Shri Sunil Kumar and Shri Umesh Kumar**.
- During these last 26 years of foundation of All India body, the representatives of All India have discussed on various issues with the Central Management at Central Office, Mumbai under the able **LEADERSHIP** of **Shri G. Karunanidhy** at every half yearly intervals.
- It is the leadership of our G. Karunanidhy who convinced the Top Management of our Bank resulting the OBC employees (from Sub-Staff to Scale II officers) of Union Bank of India are getting now **5 days Orientation Training Progamme** to prepare for **written examination**. For Scale III, IV & V, we are conducting **3 days O TP**. It is pertinent to say that the request for first OTP was considered by Bank in 1997 when no any guidelines from MoF was in existence. It was absolutely **Shri G. Karunanidhy** who got it from our mighty and pioneer Bank in affirmative initiations. We convey our hearty gratitude to the kind gesture of Top Management of our Bank.
- Management has provided an office accommodation at Chennai FGMO, however we have demanded an office accommodation at Mumbai, Varanasi, Delhi, Jodhpur, Hyderabad, Kolkata, Bihar places also.
- After a long negotiation with the management of our Bank, we are now having our **2 structured meeting at all the RO, and ONE at all the FGMOs** in a year. However we have demanded from the management for **QUARTERLY MEETING at Central Office and RO & FGMOs**.
- After the constitution of **Parliamentary Committee for OBC** in 2012, **Parliamentary Committee** have visited Union Bank of India 4 times till the year 2022. This visit has provided a room for suggestions, inputs and constrains from Association. We have raised several issues on the welfare of OBCs during these 4 interactions.
- **Lucknow Meeting** on 18/02/2023 is a successful meeting where several issues were discussed in length. **Shri**

- **K.K.Pal**, an advocate of **Lucknow High Court** graced the meeting. Shri Pal is a veteran social activist, he has also filed a case on caste based census in the honorable Supreme Court of India. Our leader Shri G.Karunanidhy has also filed a petition in the honorable SC.
- **Shri Chandra Shekhar Yadav**, a All India representative of Railway OBC Employees Welfare Association has also graced the function. He also addressed the meeting and invited our people to conduct any meeting up to 70-80 people in his Railway OBC Association Office at Lucknow.
- **Shri Prakhar Singh** from **SBI Lucknow**, has also attended the meeting and assured to participate in future activities also.
- Our participant members/office bearers have spoken on several issues. They told that they became very happy to participate in the meeting which made them aware about a lots of OBCs affairs.
- Shri G.Karunanidhy has elaborately presented the history of reservation to the audience. What was the communal GO, How article 16(4) & 15(4) inserted in the Indian Constitution etc.
- He also briefed about all the initiations taken up with the Govt of India for corrective measure by the AIOBC Federation.
- Some of the friends have surprised when they knew that all the **JMGS-1 AND ABOVE are equivalent to Class - 1 / Group A** services in Govt. of India and their children are under **CREAMY LAYER**. Their children can not apply under reserved category.
- **Dr. Amritanshu** demanded the Govt of India to review the guidelines of Ministry of Finance dated 6th Dec 2017 on the equivalence of Posts in Govt of India and suggested that DGM & above can be considered as Class 1/Group A posts.
- He also request the people of Lucknow to become the member of the Association and ask the other OBC employees to be a member of the association.
- **Vote of thanks** was delivered by Shri Abhishek Chaudhary.
